## Junior Player Privacy Notice

### **NOTE**

In this document:

- 'the Club' refers to the Philadelphia Cricket & Community Club, and, where the context allows, any official of the Philadelphia Cricket & Community Club, e.g. Committee member, team coach/manager etc and any other appointed person(s) working on behalf of the Philadelphia Cricket & Community Club.
- 'the carer' refers to any parent or legal guardian of the child.

The Club takes the protection of the data we hold about you as a member seriously and are committed to respecting your privacy. This Junior Player Privacy Notice explains how we may use and protect the personal data we obtain about you and your rights in respect of your personal data.

<b>Categories of personal data we collect</b>	<p>The Club collects:</p> <ul style="list-style-type: none"> <li>• Membership category information</li> <li>• Name</li> <li>• Home address</li> <li>• Date of birth</li> <li>• Gender</li> <li>• Contact details of the child (if over 16)</li> <li>• Contact details of the carer</li> <li>• Emergency contact details information of an alternative adult</li> <li>• Cricket experience information</li> <li>• Disability information</li> <li>• Medical information</li> <li>• Medical consent agreement information</li> <li>• Carer participation agreement confirmation</li> <li>• Club photography and video consent</li> <li>• Carer and child declaration and signature.</li> </ul>
<b>Our sources of the personal data</b>	<p>The Club obtains personal data from:</p> <ul style="list-style-type: none"> <li>• The carer applying for you to be a member of the Club</li> <li>• The England and Wales Cricket Board (ECB)</li> <li>• Leagues (where relevant)</li> <li>• County Boards (where relevant)</li> <li>• Club officials</li> <li>• Medical practitioners.</li> </ul>
<b>Automated decisions we may take</b>	The Club will not take any automated decisions about you.

<b>Purposes for which we process personal data</b>	<p>The Club will process the personal data for:</p> <ul style="list-style-type: none"> <li>• Administering your application for membership of the Club</li> <li>• Administering bookings and attendance at sessions</li> <li>• Dealing with medical needs/specific requirements</li> <li>• Supporting the delivery of cricket sessions</li> <li>• Training and competition entry</li> <li>• Reporting of participation and any incidents and of figures and trends (including equality and inclusion information)</li> <li>• Quality and improvement monitoring.</li> </ul>
<b>Who we may disclose your personal data to</b>	<p>For members under the age of 16, the carer information will be shared. On reaching 16 your personal data may also be shared to:-</p> <ul style="list-style-type: none"> <li>• Leagues where you have been nominated for/agree to play for a League</li> <li>• The ECB where you are registered for or express an interest in an ECB programme</li> <li>• The County Cricket Board that supports the local Cricket Club whose programmes you have registered for</li> <li>• Club officials for administrating training and other sessions.</li> </ul>
<b>Legal basis for processing your personal data</b>	<p>The legal basis for the collection and processing of your personal data is:</p> <ul style="list-style-type: none"> <li>• <b>For administration and programme delivery:</b> that it is necessary to fulfil the contract that you are going to enter into or have entered into with us</li> <li>• <b>For dealing with medical needs:</b> that your carer has given explicit consent or in your vital interests</li> <li>• <b>In all other cases:</b> that it is necessary for our legitimate interests which are to build a programme to encourage participation in cricket and does not prejudice or harm rights and freedoms of carers or the children that join the programme.</li> </ul>
<b>Your right to withdraw consent</b>	<p>Where your carer has given consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</p>
<b>Location of your personal data</b>	<p>The Club will keep your personal data within the European Economic Area.</p>
<b>How long we will keep your personal data for</b>	<p>The Club will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with the Club as a member.</p> <p>6 years after you cease to be a member of the Club or play an active part in the Club, we shall delete your data excepting that needed to keep historical scorecard, statistical and financial records.</p>
<b>Your rights in respect of your personal data</b>	<p>You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.</p>
